2020 TAX PENALTY AMNESTY PROGRAM

In an effort to provide financial relief to distressed businesses negatively impacted by the current economic climate, the Office of Finance will administer a Tax Penalty Amnesty Program (Amnesty Program) from October 1, 2020 through December 17, 2020. The Amnesty Program provides an opportunity to pay delinquent taxes and avoid penalties which can amount up to the equivalent of 40% of the principal tax due.

Los Angeles Municipal Code Article 1.12 Section 1 of Chapter 2, authorized the Office of Finance to waive penalties for delinquent Business Taxes, Communications, Electricity, and Gas Users Taxes, Commercial Tenant's, Transient and Parking Occupancy Taxes provided businesses paid any outstanding principal, interest and applicable fees owed to the City.

Businesses operating in the City of Los Angeles who had previously registered with Office of Finance and are either behind on paying their taxes or have underreported their business activities, and unregistered businesses who come forward during the amnesty period are eligible to participate in the Amnesty Program. Any penalties paid prior to October 1, 2020 will not be eligible for a refund. Please note that participation in the Amnesty Program is voluntary and non-participation does not impact a taxpayer's administrative appeal rights.

To apply for the 2020 Amnesty Program, either;

1/ PAY & APPLY ONLINE: Pay all your principal, interest and fees included on your billing notice and file online at **finance.lacity.org/amnesty** (you **do not** need to return this form if filing online)

OR

2/ PAY & APPLY BY MAIL: Pay all your principal, interest and fees included on your billing. Complete, sign and return the form below with your payment *and* bill stub to:
